2021 Weanling Nomination: A fee of \$150.00 must be paid on or before March 31 of the foaling year.

A \$150 nomination fee, for each foal/embryo born, will be due March 31. In the event a mare foals, producing twins, after the nomination deadline, the owner must notify the American Saddlebred office within 30 days of foaling to nominate and pay the nomination fee for the second foal. However, one foal must have been nominated by the original deadline.

National Futurity – open to weanlings, yearlings, 2-year-olds, and 3-year-olds. May be shown by an amateur or professional.

National Amateur Futurity – open to weanlings, yearlings, 2-year-olds, and 3-year-olds. Must be shown by an amateur.
